Amendment to the 2021 Unified Fee Schedule

WHEREAS, the 2021 Unified Fee Schedule was adopted by County Council through Ordinance No. 2020-062; and

WHEREAS, costs associated with providing law enforcement, traffic control, and security services as requested in agreements to hire extra-duty deputies have increased; and


WHEREAS, the proposed rate change is consistent with the desire of Whatcom County to recover a portion of the costs associated with Reimbursable Overtime; and

WHEREAS, the County Executive is authorized by County Ordinance No. 2007-070 to make modifications to the Unified Fee Schedule by Executive Order.

NOW, THEREFORE, BY VIRTUE OF THE POWER VESTED IN ME BY THE HOME RULE CHARTER FOR WHATCOM COUNTY, I HEREBY ORDER, EFFECTIVE MARCH 1, 2021, THAT THE 2021 UNIFIED FEE SCHEDULE SHALL BE AMENDED TO INCLUDE THE FOLLOWING FEES TO BE LISTED UNDER THE HEADING OF SHERIFF OFFICE:


