**WHATCOM COUNTY
EXECUTIVE ORDER 2022-03**
Amendment to the 2021 Unified Fee Schedule

WHEREAS, the 2021 Unified Fee Schedule was adopted by County Council through Ordinance No. 2020-062; and

WHEREAS, the Parks & Recreation Department is required to pay Special Hotel/Motel taxes on all transient rental income which affects Lighthouse Marine and Silver Lake Parks; and

WHEREAS, this 2% tax, established under chapter 3.36 of the County Code, impacts revenue from all campsites, cabins and overnight lodges; and

WHEREAS, the Parks Department has determined a more effective and efficient way to charge for showers, instead of using the coin operated meters which can be heavily vandalized; and

WHEREAS, Parks will nominally increase the campground rental rate to cover the costs of to maintain the showers; and

WHEREAS, the County Executive is authorized by County Ordinance No. 2007-070 to make modifications to the Unified Fee Schedule by Executive Order.

NOW, THEREFORE, BY VIRTUE OF THE POWER VESTED IN ME BY THE HOME RULE CHARTER FOR WHATCOM COUNTY, I HEREBY ORDER, EFFECTIVE JANUARY 1, 2022, REGARDLESS THE DATE OF SIGNATURE, THAT THE 2021 UNIFIED FEE SCHEDULE SHALL BE AMENDED TO INCLUDE THE FOLLOWING FEES TO BE LISTED UNDER THE HEADING OF PARKS & RECREATION DEPARTMENT:
