Ms. Bradrick called the meeting to order at 1:01 pm and declared the purpose of the meeting was to review and make a determination on challenged ballots presented to the Canvassing Board.

Amy Grasher presented the following:

1. 18 ballots were returned with no return envelope. Mr. Buckingham made a motion to reject the ballots; the motion passed unanimously.

9 ballots from Opening Board were presented to the Canvassing Board to determine voter intent. Refer to the attached report for the Board's determination (Exhibit A). Mr. Buckingham made a motion to count the ballots as directed; the motion passed unanimously.

2. Review of 602 Challenged Ballots: 2 failed ID; 60 unsigned; 246 too late; 17 empty envelope; 219 signature does not match ballots (Exhibit B) and 58 signature on letter does not match signature on envelope (Exhibit C). Of the 277 ballot envelopes presented with signatures that didn't match, 13 were accepted and 264 were rejected. Mr. Donovan made a motion to count the 13 accepted ballots and reject the other 589 ballots; the motion passed unanimously.

Mr. Buckingham made a motion to count the ballots accepted by the Board; the motion passed unanimously.

Mr. Donovan made a motion that any challenged ballot envelopes cured by 4:30 pm on Monday, November 28, 2022 be accepted and counted. The motion passed unanimously.

The final Canvassing Board meeting to certify the November 8, 2022 General Election will be Tuesday, November 29, 2022, at 10:00 am. Meeting adjourned at 2:06 pm.
