**Canvassing Board Meeting
August 2, 2022 Primary Election**

Date: August 15, 2022

Meeting began: 2:00 pm

In attendance: Diana Bradrick, Auditor (Canvassing Board Member)
Royce Buckingham, Civil Deputy Prosecuting Attorney (Canvassing Board Member)
Todd Donovan, County Council Chair (Canvassing Board Member)
Amy Grasher, Kellye Conner, Agy Pitalo, Auditor Staff

Observers: Judy Mullenix, Jan Catrell, Cam Kerst

Ms. Bradrick called the meeting to order at 2:00 pm and declared the purpose of the meeting was to review and make a determination on challenged ballots presented to the Canvassing Board.

Amy Grasher presented the following:

1. 3 ballots were returned with no return envelope. Mr. Buckingham made a motion to reject the ballots; the motion passed unanimously.

8 ballots from Opening Board were presented to the Canvassing Board to determine voter intent. Refer to the attached report for the Board's determination. Mr. Buckingham made a motion to count the ballots as directed; the motion passed unanimously. (Exhibit A)

2. Review of 807 Challenged Ballots: 59 unsigned; 434 too late; 9 empty envelope; 272 signature does not match ballots and 33 signature on letter does not match signature on envelope (Exhibit B). Of the 434 ballots challenged for being too late, 3 were in the Acme drop box and found by the team completing the final sweep of the drop boxes. It was determined that these ballots were inadvertently missed by the collection team. The ballots were determined to be on time and were accepted. Of the 305 ballot envelopes presented with signatures that didn't match, 20 were accepted and 285 were rejected. Mr. Donovan made a motion to count the 23 accepted ballots and reject the other 784 ballots; the motion passed unanimously.

Mr. Buckingham made a motion to count the ballots accepted by the Board; the motion passed unanimously.





Diana, Royce, and Todd signed the certification of the August 2, 2022 Primary Election.






