#### Category discrepancy explanation

#### VoteWA discrepancy explanation

Voter A came to the office on election day and said he hadn't voted yet, but had been given voting credit. He said he thought his landlord had accidentally voted his ballot. We provided him a ballot, and told him it would be held until we could investigate. Upon investigation of the ballot envelopes, his landlord had voted both his own and Voter A's ballot. Both ballots were accepted. After consulting with our PA the Auditor turned the situation over to the County Sheriff. Upon completion of their investigation, it was determined that:

- The mail for both parties gets delivered to the same place. The landlord's wife inadvertently picked up the ballot for Voter A along with hers and she and her husband voted the ballots immediately.
- The landlord's actual ballot came in the mail at a later date. He called our office, and because he hadn't been given voting credit yet, they told him to go ahead and vote that ballot and turn it in.
- There was no deliberate attempt to vote twice, and in fact the landlord did call our office to ask what to do with a supposed second ballot.
- Because Voter A had not had an opportunity to vote, we counted his ballot. As a result, there is one extra ballot in the count.

November 3, 2020 General Election**

Ms. Bradrick called the meeting to order at 10:04 am and declared the purpose of the meeting was to review and make a determination on challenged ballots presented to the Canvassing Board.

Amy Grasher presented the following:

1. 26 ballots were returned with no return envelope; 2 ballots without return envelopes and 2 empty return envelopes found in the same drop box as the 2 ballots; 1 provisional ballot. Mr. Buckingham made a motion to reject the 29 ballots; the motion passed unanimously.
2. 13 ballots from Opening Board were presented to the Canvassing Board to determine voter intent. Refer to the attached report for the Board's determination. Mr. Buckingham made a motion to count the ballots as directed; the motion passed unanimously. (Exhibit A)
3. Review of Rejected Ballots: 176 unsigned envelopes, 12 empty envelopes, 9 failed ID, 429 signature does not match ballots and 47 signature on letter does not match signature on envelope (Exhibit B); of the 476 ballot envelopes presented with signatures that didn't match, 7 were accepted and 469 were rejected. Mr. Buckingham made a motion to count the 7 accepted ballots and reject 666 ballots; the motion passed unanimously.

Mr. Buchanan made a motion to count the ballots accepted by the Board; the motion passed unanimously.

Mr. Buchanan made a motion that any challenged ballot envelopes cured by 4:30 pm on Thursday, March 19, 2020 be accepted and counted. The motion passed unanimously.

The final Canvassing Board meeting to certify the November 3, 2020 General Election will be Tuesday, November 24, 2020, at 10:00 am. Meeting adjourned at 12:00 pm.
