Debbie Adelstein called the meeting to order at 10:00 am and declared the purpose of the meeting was to review and make a determination on challenged ballots presented to the Canvassing Board.

Amy Grasher presented the following ballots:

1. Ten (10) ballots that were returned without a declaration ballot return envelope. The Canvassing Board's determination: reject all ten ballots. Royce Buckingham made a motion to reject the ten ballots; the motion passed unanimously. (See Exhibit A)
2. One (1) ballot for voter intent. Rud Browne made a motion to count the vote for Kris Keene; the motion passed unanimously. (See Exhibit A)
3. 275 ballot envelopes with questionable signature matches. Of the 275 ballot envelopes presented, 25 were accepted and 250 were rejected. The attached Alpha List of Challenged Voters reflects the Board's determination of the accepted ballots. Rud made a motion count the accepted ballots and to reject the ballots rejected; the motion passed unanimously. (See Exhibit B)
4. Eight (8) voter signature challenge letters where the signature did not match the signature on the declaration ballot return envelope. All 8 were rejected. The attached Alpha List of Challenged Voters reflects the Board's determination. Rud Browne made a motion to reject the 8 ballots; the motion passed unanimously. (See Exhibit C)


Royce made a motion to count the ballots accepted by the Board; the motion passed unanimously.

Royce made a motion that any challenged ballot envelopes cured by 4:30 pm on Monday, August 19, be accepted and counted. The motion passed unanimously.

Debbie announced that the final Canvassing Board meeting to certify the August 6, 2019 Primary Election will be Tuesday, August 20th, 2019, at 10:00 am.
