Debbie Adelstein called the meeting to order at 10:15 am and declared the purpose of the meeting was to review and make a determination on challenged ballots presented to the Canvassing Board.

A request was made by Brett Bonner, as representative of one of the candidate campaigns in the election, regarding who the designated Canvassing Board Members were. Debbie explained the statutory designation of the Auditor or designee, the Council Chair or designee, and the Prosecuting Attorney or designee. He asked that Mr. Browne consider recusing himself and appointing another to serve on behalf of the County Council since Mr. Browne had supported one of the candidates in the election. Mr. Browne addressed this and did not feel his decisions would be affected. The meeting proceeded.

Amy Grasher presented five provisional ballots:

1. Voter was at DOL and missed deadline to register. Debbie Adelstein made a motion to reject the ballot; the motion passed unanimously.
2. Voter was at DOL and was told he was registered. Debbie made a motion to reject the ballot; the motion passed unanimously.
3. Voter said he mailed in a registration form but we did not receive it. Debbie made a motion to reject the ballot; the motion passed unanimously.
4. Voter was previously canceled and thought he was registered. Debbie made a motion to reject the ballot; the motion passed unanimously.
5. Voter thought he registered at DOL but wasn't. Debbie made a motion to reject the ballot; the motion passed unanimously.

Amy also presented the following:

1. Twenty-one (21) ballots that were returned without a declaration ballot return envelope. Royce Buckingham made a motion to reject all 21 ballots; the motion passed unanimously.
2. Sixteen (16) ballots for voter intent. Refer to the attached report for the Board's determination. Royce made a motion to count the ballots as directed; the motion passed unanimously. (Rud Browne abstained from making a determination on four ballots involving the 42<sup>nd</sup> District Senate Race.) (Exhibit A)
3. Twenty-Six (26) voter signature challenge letters where the signature did not match the signature on the declaration ballot return envelope as required. Of the 26 letters presented, all 26 were rejected. The attached Alpha List of Challenged Voters reflects the Board's determination. Royce made a motion to reject the 26 ballots; the motion passed unanimously. (Exhibit B)
4. 422 ballot envelopes with questionable signature matches. Of the 422 ballot envelopes presented, 11 were accepted and 411 were rejected. The attached Alpha List of Challenged Voters reflects the Board's determination of the accepted ballots. Royce made a motion to count the accepted ballots; the motion passed unanimously. (Exhibit C)

Royce made a motion to count the ballots accepted by the Board; the motion passed unanimously.

Royce made a motion that any challenged ballot envelopes cured by 4:30 pm on Monday, November 26, be accepted and counted. The motion passed unanimously.

The final Canvassing Board meeting to certify the November 6, 2018 General Election will be Tuesday, November 27, 2018, at 3:00 p.m. Meeting adjourned at 12:50 pm.

Royce made a motion that the Canvassing Board reconvene at 2:30 pm to certify the results of the recount.


