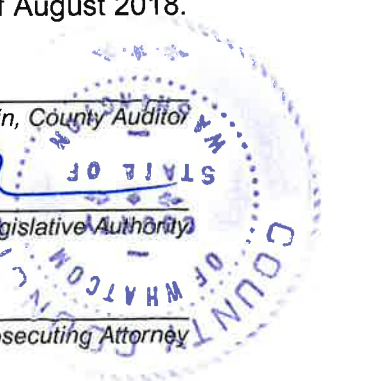

Nancy Moore, Auditor Staff

Diana Bradrick called the meeting to order at 10:00 am and declared the purpose of the meeting was to review and make a determination on challenged ballots presented to the Canvassing Board.

Amy Grasher presented the following ballots:

1. Six (6) ballots that were returned without a declaration ballot return envelope. The Canvassing Board's determination: reject all six ballots. Royce Buckingham made a motion to reject the six ballots; the motion passed unanimously.
2. One (1) ballot for voter intent. Royce made a motion to *not* count the federal races with full strikeouts and to count all other races voted on; the motion passed unanimously.
3. Seven (7) voter signature challenge letters where the signature did not match the signature on the declaration ballot return envelope. Of the 7 letters presented, all 7 were rejected. The attached Alpha List of Challenged Voters reflects the Board's determination. Royce Buckingham made a motion to reject the 7 ballots; the motion passed unanimously.
4. 294 ballot envelopes with questionable signature matches. Of the 294 ballot envelopes presented, 35 were accepted and 259 were rejected. The attached Alpha List of Challenged Voters reflects the Board's determination of the accepted ballots. Royce made a motion count the accepted ballots and to reject the ballots rejected; the motion passed unanimously.

Royce made a motion to count the ballots accepted by the Board; the motion passed unanimously.

Royce made a motion that any challenged ballot envelopes cured by 4:30 pm on Monday, August 20, be accepted and counted. The motion passed unanimously.

Diana stated that cyber security concerns initiated changes made to WAC that preclude voters other than military and overseas voters (UOCAVA) from returning an electronic ballot. The Secretary of State announced the changes are effective August 10 – December 10, 2018, and will eventually be permanently adopted. A *non-UOCAVA* voter may still download and mark their ballot but can only return it through the mail or by depositing it in an official ballot drop box.

Diana also mentioned with the implementation of the new Clear Ballot counting system, some procedural changes will need to be accepted by the Canvassing Board; i.e., adjudication and choosing batches of ballots for the manual hand count. Royce suggested adding the procedural changes to the agenda for the August 21 certification meeting.

The final Canvassing Board meeting to certify the August 7, 2018 Primary Election will be Tuesday, August 21, 2018, at 3:00 pm. Meeting adjourned at 11:25 pm.
