Debbie Adelstein called the meeting to order at 2:03 pm. She declared the purpose of the meeting was to review and make a determination on challenged ballots presented to the Canvassing Board in addition to adopting changes made to the Canvassing Guidelines.

Debbie explained with the installation of the new Clear Ballot counting system, modifications were necessary to the Canvassing Guidelines. She reviewed the proposed changes. Rud Browne made a motion to approve the modified Guidelines. He further motioned that any minor changes found subsequently could be corrected provided the changes didn't alter the substance of the Guidelines. The motion passed unanimously.

Amy Grasher presented the following ballots:

1. One (1) ballot that was returned without a declaration ballot return envelope. Royce made a motion to reject the ballot; the motion passed unanimously.
2. Two (2) voter signature challenge letters where the signature did not match the signature on the declaration ballot return envelope. Of the two letters presented, both were rejected. Royce made a motion to reject both letters; the motion passed unanimously.
3. 106 ballot envelopes with questionable signature matches. Of the 106 ballot envelopes presented, 3 were accepted and 103 were rejected. The attached Alpha List of Challenged Voters reflects the Board's determination of the accepted ballots. Royce made a motion to count the accepted ballots; the motion passed unanimously.

Rud made a motion that any challenged ballot envelopes cured by 4:30 pm on Thursday, February 22, be accepted and counted. The motion passed unanimously.

The final Canvassing Board meeting to certify the February 13, 2018 Special Election will be Friday, February 23, 2018, at 3:00 p.m. Meeting adjourned at 2:32 pm.


