Ms. Bradrick called the meeting to order at 11:05 am and declared the purpose of the meeting was to review and make a determination on challenged ballots presented to the Canvassing Board.

Amy Grasher presented the following:

1. 3 ballots were returned with no return envelope. Mr. Buckingham made a motion to reject the ballots; the motion passed unanimously.

3 ballots from Opening Board were presented to the Canvassing Board to determine voter intent. Refer to the attached report for the Board's determination. Mr. Buckingham made a motion to count the ballots as directed; the motion passed unanimously. (Exhibit A)

2. Review of 742 Challenged Ballots: 68 unsigned; 388 too late; 7 empty envelope; 272 signature does not match ballots, 6 signature on letter does not match signature on envelope, and 1 unsigned ballot where the signature on the cure letter didn't match the registration (Exhibit B). Of the 279 ballot envelopes presented with signatures that didn't match, 9 were accepted and 270 were rejected. Mr. Donovan made a motion to count the 9 accepted ballots and reject the other 733 ballots; the motion passed unanimously.

Mr. Buckingham made a motion to count the ballots accepted by the Board; the motion passed unanimously.

Mr. Donovan made a motion that any challenged ballot envelopes cured by 4:30 pm on Monday, August 14, 2023 be accepted and counted. The motion passed unanimously.

The final Canvassing Board meeting to certify the August 1, 2023 Primary Election will be Tuesday, August 15, 2023, at 11:00 am. Meeting adjourned at 12:14 pm.
