**Canvassing Board Meeting
February 13, 2024 Special Election**

Date: February 21, 2024

Meeting began: 10:00 am

Barry Buchanan, County Council Chair (Canvassing Board Member)
Amy Grasher, Kellye Conner, Becca Rouse, Auditor Staff

Observers: Jan Catrell

Auditor Henthorn called the meeting to order at 10:00 am and declared the purpose of the meeting was to review and make a determination on challenged ballots from the February 13, 2024 Special Election.

Amy Grasher presented the following:

1. 5 ballots were returned with no return envelope. Mr. Buckingham made a motion to reject the ballots; the motion passed unanimously.

23 Local Voters' Pamphlet inserts were returned instead of an official ballot. Canvassing Board directed staff to count the votes cast on the insert. For each insert, the ballot was determined and votes were duplicated to the largest precinct of each ballot style. Mr. Buchanan made a motion to count the ballots as directed; the motion passed unanimously. (Exhibit A)

2. Review of 740 Challenged Ballots: 102 unsigned return envelopes; 10 empty return envelopes; 330 too late; 280 signature does not match ballots and 18 signature on letter does not match signature on envelope (Exhibit B); of the 298 ballot envelopes presented with signatures that didn't match, 1 was accepted and 297 were rejected. Mr. Buckingham made a motion to count the 1 accepted ballot and reject the remaining 739 ballots; the motion passed unanimously.

Mr. Buchanan made a motion to count the accepted ballots; the motion passed unanimously.

Mr. Buckingham made a motion that any challenged ballot envelopes cured by 4:30 pm on Thursday, February 22, 2024 be accepted and counted. The motion passed unanimously.

Auditor Henthorn asked if there were any question regarding the changes made to the Whatcom County Canvassing Board Guidelines. The board will vote to accept the changes at the Friday, February 23 certification meeting.

The final Canvassing Board meeting to certify the February 13, 2024 Special Election will be Friday, February 23, 2024, at 10:00 am. Meeting adjourned at 10:50 am.


