**Canvassing Board Meeting
March 12, 2024 Presidential Primary Election**

Amy Grasher, Kellye Conner, Becca Rouse, Auditor Staff

Observers: Ronalee Kincaid

Auditor Henthorn called the meeting to order at 10:00 am and declared the purpose of the meeting was to review and make a determination on challenged ballots from the March 12, 2024 Presidential Primary Election.

Amy Grasher presented the following:

1. 2 ballots were returned with no return envelope, 188 Cross party voted ballots, and 293 Both party voted ballots (Exhibit A). Mr. Buckingham made a motion to reject the ballots; the motion passed unanimously.
2. Review of 2,377 Challenged Ballots: 1,461 unsigned, no party, and no party plus unsigned return envelopes; 434 too late; 26 empty return envelopes; 2 failed ID; 383 signature does not match ballots and 15 signature on letter does not match signature on envelope were reviewed by canvassing board (Exhibit B); of the 398 ballot envelopes presented with signatures that didn't match, 2 were accepted and 396 were rejected; 56 both party envelopes were reviewed by canvassing board, 1 envelope was determined to be a Republican declaration and 1 envelope was determined to be no party (Exhibit C). Mr. Buckingham made a motion to count the 3 accepted ballot and reject the remaining 2,374 ballots; the motion passed unanimously.

Council Chair Buchanan made a motion to count the accepted ballots; the motion passed unanimously.

Mr. Buckingham made a motion that any challenged ballot envelopes cured by 4:30 pm on Thursday, March 21, 2024 be accepted and counted. The motion passed unanimously.

The final Canvassing Board meeting to certify the March 12, 2024 Presidential Primary Election will be Friday, March 22, 2024, at 10:00 am.

Meeting adjourned at 10:58 am.
