Auditor Henthorn called the meeting to order at 2:30 pm and declared the purpose of the meeting was to certify the recount of the Precinct 214 Precinct Committee Officer-Democratic race for the August 6, 2024 Primary and Special Election.

Mr. Buchanan gave the Oath of Authenticity to Auditor Henthorn; Auditor Henthorn signed the oath, Mr. Buchanan and Mr. Kooistra signed as witnesses.

Ms. Rouse went over the recount process and noted that the results of the recount matched the original count with 100% accuracy. She then reviewed the Summary Report and the Precinct Abstract Report for Precinct 214. Mr. Buchanan made a motion to accept the reports presented and to certify the results of the recount; the motion passed unanimously.

Stacy, Kellen, and Barry signed the certification of the recount of Precinct 214 Precinct Committee Officer-Democratic race for the August 6, 2024 Primary and Special Election.

Auditor Henthorn informed the Canvassing Board that the manual recount for the Commissioner of Public Lands race would begin on Monday, August 26 at 8:30 am.
